FAQ's about A.A.'s History



Each year the G.S.O. Archives receives thousands of requests for research and historical information. The questions received range from very simple questions with easy answers to complex questions involving hours of research. Below is a popular question and answer:

Q. What is the story behind the Circle and Triangle logo?

A. The Circle and Triangle symbol has long been connected to the A.A. Fellowship. It was adopted as an official A.A. symbol at the International Convention in St. Louis in 1955 and from that point on was widely used in the Fellowship. In the book *Alcoholics Anonymous Comes of Age*, Bill W.'s 1955 speech, in which he describes the adoption of the symbol, is printed:

"Above us floats a banner on which is inscribed the new symbol for A.A., a circle enclosing a triangle. The circle stands for the whole world of A.A., and the triangle stands for A.A.'s Three Legacies of Recovery, Unity, and Service. Within our wonderful new world, we have found freedom from our fatal obsession. That we have chosen this particular symbol is perhaps no accident. The priests and seers of antiquity regarded the circle enclosing the triangle as a means of warding off the spirits of evil, and A.A.'s circle and triangle of Recovery, Unity, and Service has certainly meant all of that to us and much more."

Nevertheless, in the early 1990's A.A. World Services decided to phase out the "official" or "legal" use of the Circle and Triangle symbol on its literature, letterhead and other material [to avoid copyright infringement issues]; and in 1994 the General Service Conference resolved that the logo be discontinued on all Conference-approved literature. However, the symbol is still associated with Alcoholics Anonymous (and other kinds of 12-Step recovery fellowships) and has a special meaning for A.A. members all over the world.

Tradition Two by Ira C.

"For our group purpose there is but one ultimate authority- A loving God as He may Express Himself in our group conscience. Our leaders are but trusted servants, they do not govern."

In an editorial written for the AA Grapevine in January 1948, Bill W. begins by comparing the growth and development of an individual in early sobriety with the growth and development of an AA group. It was recognized early on that both the individual and the group operate on the same or similar cycles. As each individual has his or her own specific strengths and weaknesses, shortcomings and praiseworthy behaviors, so does each group.

Each AA group has a conscience much like each AA individual has a conscience. As each AA member has defects of character, so does each group. As each AA individual reaches out for God's will, so should each group. The pursuit of God's will is the guiding principle both for the AA member and the AA group. The coalescence of individual and group dependency on a "loving God" directs the thoughts, prayers and mediation of all involved. The collective conscience of a group will always prove superior to the individual no matter how long sober, how intelligent or compassionate the individual may be.

News from the General Service Office

General Manager, Phyllis H., reported that while the General Service Office was officially closed during the week of Hurricane Sandy, Staff and employees who reside in New York City stood by and supported the office.

The aa.org Website Redesign project has been placed on hold until the 2013 Budget is set.

The staff member on the International Desk attended the 11th annual meeting of MERCAA, the Middle Eastern Regional Council of Alcoholics Anonymous, which met in Kuwait. During the week prior to that, she met with members of the Fellowship in Dubai and Abu Dhabi.

Corrections Service – A Spiritual Benefit

Many recovering alcoholics get their beginning in an institution environment. None of us comes to A.A. on a winning streak.

Hagerstown Intergroup has a Corrections Committee which is a group of men and women who do service by carrying the A. A. message to potential newcomers in the institutions.

Before taking meetings into the local detention center or prison, a completed application and release forms must first be submitted for approval. The women, in pairs, take meetings to the Washington County Detention Center every Tuesday. Men, sometimes in pairs, take meetings to the detention center on Sundays and Wednesdays with a separate commitment at the Maryland Correctional Training Center (MCTC) on Tuesdays.

As a member of the Corrections Committee, I can share the rewards of sobriety, my experience with the Twelve Steps, the importance of a sponsor and the A.A. meetings with ladies who are seeking a new way of life. From personal experience I will say, without a doubt, it was an A.A. meeting brought into the jail, God, and the willingness to do whatever it took, to have today what that speaker so freely shared with me.

Acronyms
