### **Committee Reports given or sent:**

Activities committee: Whitney B. sent via text that the Round Robin luncheon was a success, attended by 75 people. Income was \$258.22 including \$150.00 seed money plus \$31.72 from the basket and \$76.50 from the 50/50. Expenses were \$405.31 for the church, copies, speaker gift card, chicken and supplies. The resulting cost of the event to Intergroup was \$147.09. Since the \$100 church donation was paid separately, Whitney is owed \$47.09 for out-of-pocket expenses. A motion was made to reimburse Whitney \$47.09 for out of pocket expenses for the Round Robin. The motion was seconded and passed unanimously by the Intergroup Reps present.
