1. Elena reported that Fellowship Hall needs to request an increase in the quarterly rent paid by HAIG due to an increase in expenses incurred. **A motion was made to increase the quarterly rent due from HAIG from \$45.00 to \$60.00. Motion passed.**
2. Brigitte invited reps to attend the virtual Area 29 Intergroup Liaison Committee (IGLC) Meeting on the first Monday of the month. The format is typically a speaker meeting and then opens for discussion committed to the problems and issues within the groups. This meeting would be a good opportunity to learn how the IGLC is a conduit for the business of the Area and the business of The General Service Board in New York. Brigitte also reported that the 5th Edition of The Big Book will be coming out sometime in Dec 2026/Jan 2027.
